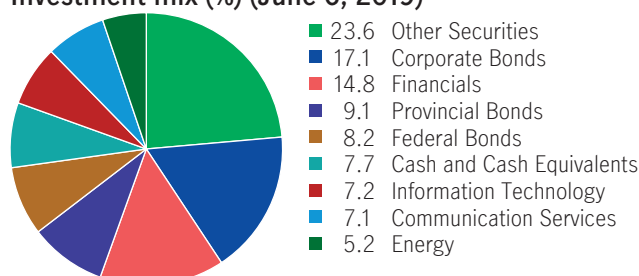
## What does the fund invest in?

The Fund's investment objective is to generate, directly or indirectly, capital appreciation and revenue. The Fund primarily invests, directly or indirectly, in a portfolio of equities and fixed income investments. The Fund may invest up to 30% of its assets in foreign securities.

The charts below give you a snapshot of the Fund's investments on June 6, 2019. The Fund's investments will change.

## How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

The Manager has rated the volatility of this Fund as **low to medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

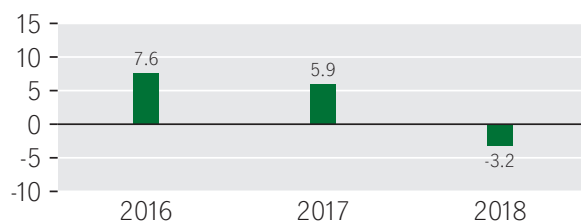
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the fund performed?

This section tells you how the Series F securities of the Fund have performed over the past 3 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

### Year-by-year returns

This chart shows how the Series F securities of the Fund have performed in each of the past 3 years. The Fund dropped in value in 1 of 3 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series F securities of the Fund in a 3-month period over the past 3 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Best return	8.49%	March 31, 2019	Your investment would rise to <b>\$1,085</b>
Worst return	-5.22%	December 31, 2018	Your investment would drop to <b>\$948</b>

### Average return

The annual compound return of the Series F securities of the Fund was 5.47% since November 30, 2015. If you had invested \$1,000 in the Fund on November 30, 2015, on June 30, 2019 your investment would now be worth \$1,210.

### Who is this fund for?

The Fund is suitable for investors who:

- Are seeking the benefits of a diversified mix of equities and fixed income instruments
- Are comfortable with and understand the risks of investing in the equity market and are investing for the medium to long term
- Are willing to accept a low to medium level of investment risk

### A word about tax

In general, you'll have to pay income tax on taxable distributions made to you by the Fund and on any gains you make if you redeem your securities in the Fund. How much you pay depends on the tax laws that apply to you and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F securities of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### Sales charges

Series F securities of the Fund are not subject to sales charges.

### Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the Fund. As of April 30, 2019, the Fund's expenses were 1.12% of its value. This equals \$11.20 for every \$1,000 invested.

	Annual rate (as a % of the Fund's value)
<b>Management expense ratio (MER)</b> – This is the total of the Fund's management fee, a fixed administration fee and certain specified operating expenses. The Manager waived some of the Fund's expenses. If it had not done so, the MER would have been higher.	1.09%
<b>Trading expense ratio (TER)</b> – These are the Fund's trading costs.	0.03%
<b>Fund expenses</b>	<b>1.12%</b>

### More about the trailing commission

No trailing commission is paid in respect of the Series F securities.

### Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Fund.

Fee	What you pay
<b>Short-term trading fee</b>	2.0% of the value of securities you sell or switch within 7 days (for market timing) or 30 days (for excessive trading) of buying them. This fee goes to the Fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2.0% of the value of securities you switch to another mutual fund.
<b>Fee-based arrangements</b>	Series F securities require investors to participate in a fee-based arrangement with their representative's firm. Fees in connection with such arrangements are negotiated between you and your representative's firm.
<b>Dealer service fee</b>	You may be required to pay your representative's firm a fee on a quarterly basis for investment advice and other services. The Dealer Service Fee may not be offered but, if offered, is optional and negotiable between you and your dealer up to a maximum of 1.25% per annum. If your dealer does not advise us on the amount of the negotiated Dealer Service Fee, we will deem it to be zero. If available, the Manager pays the Dealer Service Fee to your representative's firm on your behalf, at a minimum quarterly, by redeeming your Series F securities in the Fund and forwarding the redemption proceeds to your representative's firm. By purchasing Series F securities in the Fund, you authorize the Manager to do this. This Dealer Service Fee should not be charged if you are already paying a fee as part of a fee-based arrangement.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund securities within two business days after you receive a Simplified Prospectus or Fund Facts document, or
- Cancel your purchase order within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the Simplified Prospectus, Annual Information Form, Fund Facts document or Financial Statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
