### WHAT DOES THE FUND INVEST IN?

The Fund's investment objective is to achieve long-term capital appreciation. The Fund seeks to accomplish its objective by primarily investing in securities of Underlying Funds and/or ETFs. These Underlying Funds and/or ETFs generally invest in domestic and global equity securities and/or domestic and global fixed income securities.

The charts below give you a snapshot of the Fund's investments on June 6, 2018. The Fund's investments will change.

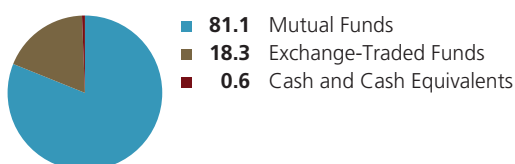

### HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

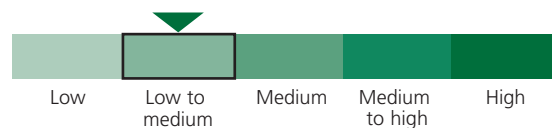
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk rating

The Manager has rated the volatility of this Fund as **low to medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

## HOW HAS THE FUND PERFORMED?

This section tells you how the Series T6 securities of the Fund have performed since its inception. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

### Year-by-year returns

Since the Series T6 securities of the Fund have been available for distribution for less than a full calendar year under a simplified prospectus, performance information is not available.

### Best and worst 3-month returns

Since the Series T6 securities of the Fund have been available for distribution for less than a full calendar year under a simplified prospectus, performance information is not available.

### Average return

The annual compound return of the Series T6 securities of the Fund was 3.01% since May 5, 2017. If you had invested \$1,000 in the Fund on May 5, 2017, on June 30, 2018 your investment would now be worth \$1,035.

## WHO IS THIS FUND FOR?

The Fund is suitable for investors who:

- Are seeking a diversified portfolio of Canadian and global equity and fixed income securities
- Are seeking long-term growth potential with a greater emphasis on the equity portion of their portfolio
- Are looking for a simple and easy way to diversify their investments
- Prefer a low to medium level of investment risk
- Are investing for the long term – more than 5 years
- Are seeking regular monthly cash flows consisting of net income and/or a return of capital

## A WORD ABOUT TAX

In general, you'll have to pay income tax on taxable distributions made to you by the Fund and on any gains you make if you redeem your securities in the Fund. How much you pay depends on the tax laws that apply to you and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

## HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series T6 securities of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### Sales charges

You have to choose a sales charge option when you buy the Fund. Ask about the pros and cons of each option.

### Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the Fund. As of December 31, 2017, the Fund's expenses were 2.47% of its value. This equals \$24.70 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the Fund's management fee (which includes the trailing commission), a fixed administration fee and certain specified operating expenses. The Manager waived some of the Fund's expenses. If it had not done so, the MER would have been higher.	2.38%

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and/or advice that your representative and their firm provide to you.

The Manager pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

### Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Fund.

Fee	What you pay
<b>Short-term trading fee</b>	2.0% of the value of securities you sell or switch within 7 days (for market timing) or 90 days (for excessive trading) of buying them. This fee goes to the Fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2.0% of the value of securities you switch to another mutual fund.

### WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund securities within two business days after you receive a Simplified Prospectus or Fund Facts document, or
- Cancel your purchase order within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the Simplified Prospectus, Annual Information Form, Fund Facts document or Financial Statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
