Distributions: Monthly, generally at month end. For non-registered accounts, distributions are generally paid in cash. For registered accounts, other than TFSAs, distributions must be reinvested. For TFSAs, a cash distribution can be selected.

What does the fund invest in?

The fundamental investment objective of the Pool is to seek to generate income and capital appreciation primarily through exposure to a diversified portfolio of Canadian and U.S. investment grade and high yield corporate bonds.

How risky is it?

The value of the Pool can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Pools with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

The Manager has rated the volatility of this Pool as low.

This rating is based on how much the Pool's returns have changed from year to year. It doesn't tell you how volatile the Pool will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.


Like most mutual funds, this Pool doesn't have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how the Series FT6 securities of the Pool have performed over the past 6 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

Year-by-year returns

This chart shows how the Series FT6 securities of the Pool have performed in each of the past 6 years. The Pool dropped in value in 2 of 6 years. The range of returns and change from year to year can help you assess how risky the Pool has been in the past. It does not tell you how the Pool will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series FT6 securities of the Pool in a 3-month period over the past 6 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

The annual compound return of the Series FT6 securities of the Pool was 3.87% since December 14, 2012. If you had invested \$1,000 in the Pool on December 14, 2012, on June 30, 2019 your investment would now be worth \$1,282.

Who is this fund for?

The Pool is suitable for investors who:

- Are looking for diversification and incremental return potential within the fixed income universe
- Are looking for income
- Are looking to invest in investment-grade corporate and high yield honds
- Are looking for incremental returns with less volatility than provided by the equity markets
- Prefer a low level of investment risk
- Are investing for the medium to long term
- Are seeking regular monthly cash flows consisting of return of capital and/or net income

A word about tax

In general, you'll have to pay income tax on taxable distributions made to you by the Pool and on any gains you make if you redeem your securities in the Pool. How much you pay depends on the tax laws that apply to you and whether or not you hold the Pool in a registered plan, such as a Registered Retirement Savings Plan or Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series FT6 securities of the Pool. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

Sales charges

Series FT6 securities of the Pool are not subject to sales charges.

Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the Pool. As of December 31, 2018, the Pool's expenses were 0.84% of its value. This equals \$8.40 for every \$1,000 invested.

	Annual rate (as a % of the Fund's value)
Management expense ratio (MER) – This is the total of the Pool's management fee, a fixed administration fee and certain specified operating expenses. The Manager waived some of the Pool's expenses. If it had not done so, the MER would have been higher.	0.84%
Trading expense ratio (TER) – These are the Pool's trading costs.	0.00%

More about the trailing commission

No trailing commission is paid in respect of the Series FT6 securities.

Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Pool.

Fee	What you pay		
Short-term trading fee	2.0% of the value of securities you sell or switch within 7 days (for market timing) or 30 days (for excessive trading) of buying them. This fee goes to the Pool.		
Switch fee	Your representative's firm may charge you up to 2.0% of the value of securities you switch to another mutual fund.		
Fee-based arrangements	Series FT6 securities require investors to participate in a fee-based arrangement with their representative's firm. Fees in connection with such arrangements are negotiated between you and your representative's firm.		

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund securities within two business days after you receive a Simplified Prospectus or Fund Facts document, or
- Cancel your purchase order within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the Simplified Prospectus, Annual Information Form, Fund Facts document or Financial Statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
